SYSTEMA-TIZATION OF APPROACHES TO THE ASSESSMENT OF THE DEBT SECURITY AND ITS COMPONENTS IN UKRAINE IS PRESENTED

Kulinska A., PhD, Associate professor, Marketing and Management Department, Donetsk Mykhayilo Tugan-Baranovsky National University of Economics and Trade

The purpose of this article is to study the critical level of public debt. The critical level of public debt allows saving the stability of the financial system, the ability to make payments on obligations, the level of solvency and credit rating. But exceeding the critical level of public debt is a threat to the debt security of the country.

When assessing the level of debt burden in the state, one should, from the point of view of methodology, differentiate between the following concepts: the solvency of the country in the broad sense (or common solvency) and the solvency of the country in the narrow sense (or liquidity).

The first term refers to the ability of the debtor country to attract investment and to service its external debt without violating the reproduction process. Total solvency in the international practice is calculated using indicators, which compare the volume of external debt with the basic settings of the reproduction process.

Interpretation of the country's solvency as liquidity implies the existence of a certain amount of the international payment funds sufficient to repay the current debt obligations. Liquidity evaluation is based on comparing the current (projected) payments on external debt with available (estimated) volumes of liquid resources (export revenues, foreign exchange reserves, reserve position etc.). Accordingly, the debt crisis as a general crisis of solvency differs from liquidity crisis, as the latter may be the first symptom or occur independently.

A qualitative characteristic of the state debt security is the definition of the debt burden and the level of solvency. The evaluation of these parameters is carried out by means of indicators and their limit (threshold) values. The number of indicators and their threshold values is determined by the diversity of methodologies applied for their calculation, the specific calculation, applying the macroeconomic indicators of the country, originating debt (public or private) and sources of its repayment.

Acute is the question about the indicators developed for the assessment of the debt security, which today are not grouped into a single system and do not have the agreed limit values. The problem is that those indicators and their threshold values, which are suitable for accurate assessment of the debt security of one group of countries, may not work with another. Therefore, the article attempts to systematize international and national approaches to assessing debt security of Ukraine at the present stage of development.

The methodology suggested by the author, was developed with the aim of determining the level of economic (particularly financial and its components) security of Ukraine as the main component of the national security and defines the list of basic indicators of Ukraine's economic security and their optimal (threshold or limit) value.

BANKING PANIC IN UKRAINE: DRIVERS, DYNAMICS AND CONSEQUENCES

Roman Kornyliuk, Ph.D, doctoral candidate, Banking department, Vadym Hetman Kyiv National Economic University

This article investigates the banking panic phenomenon during Ukrainian systemic crisis of 2014-2015. Retrospective analysis of the bank deposit outflows dynamics was conducted, taking into account the banks' solvency level and origin of owners. Particular attention is paid to the different bank response to panic, role of deposit rates and informational contamination channel in realization of the systemic risk. On the basis of analysis some recommendations for Ukrainian bank regulators, managers, savers and counterparties were made.

INTERNAL CONTROL ORGANIZATION IN THE INDUSTRY

The problems of practical implementation of the internal control at industrial enterprises are under study. Interpretation of the term «internal business control» has been studied. In general, internal control is a system of measures taken within the company without any extraneous factors and aimed at improving the performance, which is achieved by preventing and detecting facts of deviations, violations, abuse, waste or inefficient use of assets, installations and their causes, developing a mechanism for the deviations correction.

Correct organization of internal control is one of the main factors that helps businesses mobilize limited resources for the maximum profit.

Internal control should be organized as an integral system of interrelated methodologies, techniques and methods that cover the entire range of control procedures, starting with the formation of the information base, the audit trail and ending in generalization of the test results. Industrial enterprises are dependent on the legal form, the types and extent of activities, complexity of organizational structure, availability of sufficient financial resources, feasibility coverage control, relationship and various aspects of management to be controlled.

Expediency of creating the internal control service at an enterprise has been proved. The main goal of this service is to verify the company's efficiency and to monitor its activities. The direct subordination of the internal control service manager will allow to efficiently control individual units of production and reserves, identify the most promising fields of development, and make recommendations to the financial, economic and accounting departments regarding improvement of their work results.

Factors, recommended to be considered, when organizing the internal control service at the enterprise, are established as follows:

- -control functions performing should be entrusted to persons who have sufficient experience in the subject matters of control:
 - workers, who exercise control, should not be related only to material interests of affiliated units;
 clear definition of the functions, objectives and tasks of employees at the department;
- development and implementation of advanced methods, techniques and control methods, best adapted to the tasks of the control checks:
 - the self-control presence.

Stages of life and activities of the internal control are defined in the industrial, research, preparatory, organizational spheres, for the purpose of efficient control activities implementation.

The issue of service and structure of the internal control at the company, is not fully regulated by the law. In this respect, there is a need to improve the regulatory framework regarding the internal control, need for development and adoption of the Law of Ukraine on internal control, clearly defining the limits of liability in the law division, the functions of audit and assurance, development of the internal control and audit standards at

In order to improve the internal control organizing process in the industry, it is appropriate to create a special independent unit, within the structure of the company it may be the internal control service, that will permit efficient monitoring, to identify the most promising fields of development and to provide recommendations for the company improvement.
